 - To reduce the risk of preventable hospitalizations for adults with diagnosed Alzheimer's disease and other dementias.
- Development of briefs to educate state policy makers and guide their implementation of brain health initiatives.
- Research to understand public perceptions about brain health (the Healthy Brain Study), which I led as PI for 3 years while on the faculty of the Arnold School at the University of South Carolina.

- Used national social marketing tools (DocStyles and HealthStyles) to assess attitudes and practices of the general public and healthcare providers with respect to cognitive health.
- Over 2007-2012, Healthy Brain Study participants made more than 70 formal presentations at local, national, and international meetings.
