To require face coverings in classrooms and labs:

It is the policy of UNC Charlotte for Academic Years 2020-2021 and 2021-2022 that as a condition of on-campus enrollment, all students are required to engage in safe behaviors to avoid the spread of COVID-19 in the 49er community. DESCRIPTION.

Spoken and written language related to communicative needs for healthcare professionals. Emphasis on terminology, phraseology, and etymology necessary for effective communication in principal healthcare and medical fields and settings.

- <u>Expectations:</u> SPAN 3222 is a 3000-level terminology-oriented course with a focus is on specialized communication, terminology building and phraseology. Students enrolled in this course are expected to have mastered basic grammatical concepts (agreement; verb conjugations: present, past, future; pronouns), understand indicative, imperative, and subjunctive moods, direct and indirect speech, and read and write at an advanced intermediate proficiency level.
 - If you are weak in any of these skills, it is your responsibility to study and improve them on your own!

LEARNING OUTCOMES

By the end of the course, the learners should be able to:

- Communicate effectively using basic and specific medical terminology and phraseology in Spanish.
- Gain awareness of medical etymology in English and in Spanish.
- Discuss in Spanish a variety of health-related topics in a variety of communicative settings.
- Access resources and databases to improve the use of medical terminology in Spanish.
- Learn about and report on basic medical topics and procedures in Spanish and gain knowledge of common medications and their uses.
- Gain awareness of a range of healthcare issues as relating to the Hispanic/Latino patient.

<u>GUIDELINES</u>. As in the real world of medical and health care, you are expected to be punctual and to attend each class <u>very well prepared</u> and with <u>a positive attitude toward being in the class (which is the equivalent of being at</u> <u>work)</u>. Well prepared means you are alert, focused, and engaged in the class. I take roll at the beginning of each class, not after the class has begun. <u>If you are late and I have already taken roll, you are absent</u>. Please come to class at least 5 minutes before the class actually begins.

Your active, voluntary, and positive attitude participation is required—no credit for simply showing up!

- Active participation means that you:
 - Speak Spanish once you enter the classroom
 - Make positive, thoughtful, and relevant contributions to the class
 - Volunteer to answer and ask questions, rather than wait to be called on
 - **Lead** and **involve fellow students** in classroom discussions and activities

More than three (3) *unexcused* absences will result in your final grade (evaluation of job performance) being lowered automatically by five points (half a letter grade) for each absence thereafter. In other words, keep track of your absences, check on these with your professor, and DO NOT MISS MORE THAN THREE CLASSES DURING THE **SEMESTER (including those formally accommodated by the University)!** Should **extenuating** circumstances require you to miss a class beyond the limit of three, **you are expected** to provide me well **in advance** with a formal written justification or send an email (also well in advance). My being informed after the fact is generally unacceptable. *Excepting formally excused classes by the University (see, for example, religious obligations in accordance with <u>University Policy #409: Religious</u> <u>Accommodation for Students</u> (Links to an external site.)), <u>no late work will be accepted</u> and there will be <u>no make-up quizzes</u> <u>or exams. There is absolutely no make-up work for extra credit</u>.
