**2015 ICMH at Beijing, China.** The Chinese Commission on Military History is proceeding with its preparations for the September international congress. There have been some communications problems – and apparently, for whatever reason, sending e-mails using older versions of Outlook may not be received. Also, some visa issues. Dr. Hans Pawlisch has the most recent information on this.

With respect to possible USCMH attendance at Beijing, indications from USCMH members responding to the spring mail out and current as of June 2015 are:

Definitely attending: 16 (includes 3 spouses)

Considering attending: 6

Thus, if all who have indicated they will be attending can actually do so, the U.S. Commission on Military History will be very well represented.

**2016 ICMH in Istanbul, Turkey.** At the 2014 ICMH in Varna, Bulgaria, members of the Turkish Commission briefed on plans for the 2016 congress. A fine briefing with much to appeal to members of the USCMH, from the possible papers to accommodations (Hilton – at which my wife and I have stayed) to the historic and contemporary sites and attractions of Istanbul. As with past congresses, this should be an excellent one. USCMH members should begin planning now for next year. (NOTE: The briefing pertained to the official congress; no comments were made about the post-conference trip. Information will come on this in the future.) Proposals for papers for this congress should be sent to the USCMH Vice President – and it is not too soon to be communicating with Dr. Randy Papadopoulos reference any ideas you have which could lead to a formal proposal.

New Members. The U. S. Commission on Military History is a small but diverse organization. Reflective of this, the USCMH has members from Australia (1), Britain (1), Canada (1), Finland (1), and Germany (4).

As with any such entity, new blood, i.e., members, are necessary. As I have noted in previous communications, if you know potential members who are interested in military history, especially with an international perspective, please encourage them to contact me. I shall follow-up such contacts. In this regard, because of our eclectic character, consider serving and retired members of the armed forces and government employees; all are welcome – and members with diverse interests and experiences enhance our own professional understandings and insights.

Please emphasize that that the U.S. Commission is an open and diverse one. The key is an interest in military history (or national security affairs), especially with regard to the international aspects of the profession of arms and its related association with the diverse aspects of military history. Our members' interests and perspectives, coupled with those members of other national commissions, ensures a unique opportunity for individual personal and professional growth as the broad field of military history is researched, presented, and interpreted from many different perspectives.

A basic question will arise in such discussions: "What benefit is the USCMH to me?" Amongst the possible responses are:

- a. The USCMH is a small and personable organization.
- b. Our members are responsive to each other.
- c. There is an international perspective to the work of and interest in military history beyond that of the U.S.
- d. Annual international congresses hosted by a national commission recognized by the ICMH, the benefits of which span the spectrum from papers presented and colleagues met to the host countries and cities in which the congress is held annually.
- e. The U.S. Commission has a number of presentation slots at each ICMH annual congress, thus an opportunity is available for USCMH members to present papers before international peers and receive responses to each presenter's scholarly work.
- f. For younger members in the profession, the possibility of a travel stipend to an annual congress.
- g. Several ideas are being discussed by the USCMH leaders on how the USCMH can bring more benefits to its membership. These include having a second annual event and including in our newsletters papers presented by our members at the annual ICMH congress.

Archival Notes: The National Archives (formerly the Pubic Record Office), Kew, England. As with any institution, the physical layout, procedures, and rules can change. Yours truly in April had to renew his reader's ticket. Members in a similar situation or planning on obtaining their initial one, please note the following:

a. Applications can be completed on line within two weeks of arrival at Kew.

- b. If not done, even if holder of a previous reader's ticket, the entire process will commence as if a previous one has not been held.
- c. Hence, a longer wait will ensue.
- d. A review of archival procedures is required, a video. En excellent idea, no matter how experienced a researcher one is.
- e. Have identification ready; a current photograph also will be taken for your reader's ticket.
- f. For reproduction fees, money can be included on the ticket.
- g. In reality, this is all fairly easily done.

Certain areas of Kew are open for research without a reader's ticket. This includes the room where hard copies of the carious record groups exist, as well as many of the official lists published by various agencies of the British government, e.g., The Navy Lists, The Army Lists, etc. Some material is also available on microfilm. If a member has not been recently at Kew, note that there has been some reorganization in the physical arrangements but this is not a major issue.

The search rooms are well lighted and conducive to a favorable research experience. Also, please note that personnel in the purple smocks are attentive to how records are treated. Any indication of improper use, e.g., how bound volumes are open for work which violate procedures, polite but stern guidance on how they should be placed will be given to a researcher.

Photography is permitted, but no flash. Hence, ensure that the flash is off on cameras. Kew also does physical photocopying or copying to microfilm or cd, all for a price. A capability of using Kew cameras (fixed) to take photos of documents and sending to an e-mail address is also possible.

If in possession of a reader's ticket, documents can be ordered in advance of arrival at Kew. If this is not done, the time interval between ordering documents and their arrival in the search room can vary from 15 minutes to several hours. Documents are placed in a lettered-number locker which corresponds to a researcher's seat location.

From Central London, travel to Kew can take about an hour via tube. Driving is an option, but getting to and from Kew and its parking lot can be a challenge. Hence, coming by various combinations of rail should be considered as the primary option. Once at the station, a ten minutes walk to The National Archives will bring the researcher to his place of work. Security in the search rooms is tight; this means certain items are not permitted to be taken into them, such as coats, pens, brief cases, etc. Lockers, at no cost, are available for such items. Transparent plastic bags are available for cameras, computers, note cards and paper, and pencils. Individuals entering the secure search rooms are checked upon entering and on departure. Note that The National Archives has excellent dining and beverage facilities, ranging from a tea/coffee and cake area to a full range cafeteria. Equally important, the bookstore at Kew is superb – with its offerings ranging from The National Archives publications to recent academic and popular works to reprints of many historical items.

There is also a small museum. Finally, The National Archives has a nice park, to include ponds with ducks and other fowl, before the pubic entrance and on one side of the building; researchers should take time to enjoy this aspect of being at Kew before or after their research day; the waterfowl are indeed friendly.

**November 2015 Annual Meeting.** As plans are finalized for this event, to include the Collins prize recipient and his presentation, information will soon be forthcoming.

#### **Conference Announcements**

#### 83rd Annual Meeting of the Society for Military History

The Society for Military History is pleased to call for papers for its 83<sup>rd</sup> Annual Meeting, hosted by the Canadian War Museum and the Canadian Museum of History.

"Geography as history" is one of the Canadian War Museum's overarching themes, reflected throughout its permanent galleries in discussions of topography and its influence on battle, and the gradual conquest of distance by technology, population movement, and communications. Wars are now fought on and over the surface of the earth; on and under its adjacent oceans; in space; in the electromagnetic spectrum; and across the Internet. Traditional boundaries are regularly transgressed, imperfectly administered, and unevenly acknowledged. Moreover, fighting forces can blend with civilians in asymmetric warfare, blurring the lines between combatants and non-combatants. Borders and boundaries - geographic, political, or conceptual - remain important to the study of military history. For the 2016 SMH meeting, the program committee will consider paper and panel proposals on all aspects of military history, while especially encouraging submissions that reflect on this theme.

Panel proposals must include a panel title (along with the full names and institutional affiliations of each participant and the full title of each paper), a one-page abstract summarizing the theme of the panel, a one-page abstract for each paper proposed, and a one-page curriculum vitae for each panelist (including the chair and commentator), with email addresses and other contact information provided for all participants.)

Submissions of pre-organized panels are strongly encouraged and will be given preference in the selection process. Individual paper proposals are also welcome and must include a one-page abstract of the paper, one-page vita, and contact information, including email. If accepted, individual papers will be assigned by the program committee to an appropriate panel with a chair and commentator. All submissions should be sent in a single PDF document which includes all elements (abstracts, CVs, and contact information). Submissions sent in different formats will not be accepted.

Participants may present one paper, serve on a roundtable, or provide panel comments. They may not fill more than one of these roles during the conference, nor should they propose to do so to the Program Committee. Members who act as panel chairs for only one session may deliver a paper, serve on a roundtable, or offer comments in a different session. Members who serve as both the chair and commentator of a single session may not present in another session.

All proposals must be submitted electronically to the program committee by **October 1**, **2015**. The address is: <u>SMH2016@warmuseum.ca</u>. <u>All presenters, chairs, and commentators must be members of the Society for Military History by December 31, 2015</u>.

The meeting will be held at the Ottawa Marriott Hotel in Ontario, Canada. It is located near the Canadian War Museum and Canada's Parliament Hill.

#### **Society of Civil War Historians**

The Society of Civil War Historians will host its biennial conference at The Chattanoogan Hotel, Chattanooga, Tennessee, from **June 2 through 4, 2016**. The SCWH welcomes panel proposals or individual papers on the Civil War era, broadly defined. The goal of the conference is to promote the integration of social, military, political, and other forms of history on the Civil War era among historians, graduate students, and professionals who interpret history in museums, national parks, archives, and other public facilities.

The deadline for receipt of proposals is **September 11, 2015**. Please complete a submission form (panel proposal: <a href="http://richardcenter.psu.edu/conference-papers/panel-submisssions-form">http://richardcenter.psu.edu/conference-papers/panel-submisssions-form</a>; single paper proposal: <a href="http://richardscenter.psu.edu/conference-papers/single-paper-submission">http://richardscenter.psu.edu/conference-papers/single-paper-submission</a>) and upload a single PDF file. Proposals should include a title and abstract for the papers (approximately 250-300 words) and a short curriculum vitae from each participant. Panel submissions should have an overall title and statement about the thrust of the session.

Final decisions on submissions will be made at the Southern Historical Association meeting in Little Rock, Arkansas, on November 11-14, 2015.

#### **Medical History of the Vietnam War**

On March 10-12, 2016, the Vietnam Center and Archive at Texas Tech University, Uniformed Services University of the Health Sciences, and the Army Medical Department Center of History and Heritage will be co-sponsoring a conference on the medical history of the Vietnam War. This two-day conference will be hosted at the Doubletree Hotel, San Antonio, Texas.

Presentations on all facets of medicine and healthcare related to the Vietnam War are welcome to include historical understandings of military medicine as practiced by all participants and in all geographic regions, the repercussions of the war on the practice of medicine, medicine in various campaigns, medical care outside of Vietnam, effects on the home front, postwar medical issues, mental health issues, and related topics.

Conference organizers welcome both individual presentation proposals as well as pre-organized panel proposals that include two to three presentations. Conference sessions will follow the standard 90 minute format to include one hour for presentations and 30 minutes for questions and discussion. Presentations by veterans are especially encouraged as are presentations by graduate students. All of the conference organizers are partners with the Department of Defense's Vietnam War Commemoration. In keeping with that partnership, there will be a dignified event to thank veterans for their service.

<u>Proposal submission deadline is October 31, 2015</u>. Please send a 250 word abstract and separate two-page CV/resume to steve.maxner@ttu.edu. If submitting a panel proposal, please include separate abstracts for each proposed presentation and CVs/resumes for each speaker.

#### American Use of Strategic Landpower since 9/11

The U.S. Army War College seeks papers for a conference on "American Use of Strategic Landpower since 9/11" to be held at Carlisle Barracks, PA, from December 2-4, 2015.

In the decade following America's involvement in the War in Vietnam, Colonel Harry Summers—a researcher in the War College's Strategic Studies Institute—analyzed the Army's performance in that conflict. His *On Strategy: The Vietnam War in Context* (1982) was a controversial landmark study of the use of military force, particularly landpower. In the spirit of *On Strategy*, the War College now seeks to examine the American use of landpower since the terror attacks of September 11, 2001 through multiple strategic perspectives.

The Army defines landpower as "the ability—by threat, force, or occupation—to gain, sustain and exploit control over land, resources, and people" (Army Doctrine Reference Publication 3-o). The employment of strategic landpower thus seeks to accomplish these tasks in pursuit of policy ends.

There are many possible paper topics associated with strategic landpower. They include: the evolving nature of war; strategic analysis of Operation Enduring Freedom and Operation Iraqi Freedom; perspectives of regional combatant commands and theater armies; landpower issues associated with the reserve components and institutional army; ground force modernization and transformation; civil-military relations; roles of the interagency and non-governmental organizations; and law and ethics of war. This is far from an exhaustive list, and the War College welcomes all serious proposals on relevant topics.

Details: Panels are preferred but individual papers will be considered for acceptance. Panel presentations will last 90 minutes and consist of 20-minute (each) presentations from three panelists, a 10-minute synthesis from the moderator/commentator, and a 15-minute question-and-answer period. By **15 August 2015**, submit an abstract (no more than 250 words) for a proposed panel or individual paper to Major Jason Warren, Ph.D., at <a href="majoson.w.warren.mil@mail.mil">jason.w.warren.mil@mail.mil</a>. Panel abstracts must include an abbreviated curriculum vitae (no more than 3 pages) for all participants. The War College will announce the accepted panels and papers no later than **30 September.** Selected participants will submit their fully annotated final papers of 3,000-5000 words to the above email address one week prior to the conference. The War College will fund accepted panelists' travel, lodging, and per diem.
